

PrideFest also provides a safe space for personal expression in a diverse community environment. Estimated Parade attendance was 35,000, PrideFest attendance was 14,000. This event is intended to kep LGBTIQ people become more comfortable with who they are and to educate the public toward a better understanding of LGBTIQ issues while combating inaccuracies and stereotypes.

OUTSTANDING AWARDS - An event that honors lesbian, gay, transgender, intersex and queer (LGBTIQ) people, organizations and our allies who have made a significant impact for positive cultural change or have provided safe places for LGBTIQ people. This event also provides an opprtunity to network and share information related to the promotion and organization of pride celebrations, educational events and to inform the general public of our LGBTIQ resources.
